Everyone will bring their coolers since we had a shortage last year Vince will bring the generator, tables, chairs. The CCT tent will be used to cover the sales area. (It is stored in the Historic Building).

**Fliers** for the summer Purse Bingo are available for distribution.

**Purse Bingo** – Dave Fine – Everything is signed with St Michaels, Insurance rider is to be issued. Liquor license is being worked due to processing troubles. The license also covers pull-tabs.

**Car Wash** – Lowell – Is investigating.

Security Camera – Dave Fine – Contacted Fair Board about interest in assisting with security cost. John Fifer will meet with the Commissioners with Denise after the tax season to see if they would help to cover these costs. At this point the talks are solely between the CCT and the FB. Deb (FB) indicated they could get a grant to cover their portion of the costs. At this point the FB was interested in a system to cover their assets.

**Displays:** Denise – She showed Sherwood their displays and provided options to increase their display. They approved increasing their display. She also asked the board to work to hit the bushes to get new businesses interested in the CCT.
