Course Description: Flat, a little gravel, mostly pavement. Water will be distributed on the course. Starting at the Grandstand, you will go south towards Harness Racing Barns and snake through campgrounds exiting the fairgrounds through the maple street gate turning right onto Hicks Street, then right on Perry Street then left on Rackstraw Street then left on Ogen, then left on Hicks Street and enter fairgrounds through the Maple street gate and continue the rest of the way through the lights.
